4.6 Geolocation

The use of Geolocation must be seen as a compulsory security measure such as any other security device, harnesses or other. It is, therefore compulsory.

During the entire rally, cars <u>MUST be equipped</u> with a tracking device which will be given during the Technical scrutineering before the trial in exchange of a deposit of **200 euros** (cheque or cash).

This deposit will be returned at the return of the tracers, except in the case where the tracer is not returned within the indicated time.

In case of withdrawal, the tracers must be returned to the P.C. of the rally, or failing that, given to an official of the event. If this is not possible, the tracers must be returned by parcel the day after the test at the latest to the following address:

The league commits to giving back this deposit even if the device would be totally destroyed or damaged in case of any **accident** during the rally.

Operating and rental costs are $10 \in \text{per car}$.

There is no need to provide connections, these trackers are self-powered for the duration of the rally.

During the entire rally, any team caught without the device or perforating the device's protection film will be sanctioned by the officials even leading to an exclusion.

ARTICLE 6P. SITES ET INFRASTRUCTURES

6.1P. Description

The 49th Jean De La Fontaine "Ville de Soissons" rally has a total distance of 390.80 km, with 251.70 km for the liaison.

This rally is divided into 2 legs and 6 sessions including 11 special stages SS: distance139.10 km.

Marshals will have to be identifiable by distinct signs: Fluorescent safety vests, overalls...etc

<u>7.2.16P</u>

The calculation of any possible standard timing rates will be given by the officials using the geolocation tracking information. If this data cannot be exploited, regular methods will be used.

<u>7.5.17.1 P</u>

Withdrawals:

<u>7.5.17.2P</u>

The tracking devices have a "**Panic**" button that should <u>only be used</u> in case of <u>serious</u> <u>medical help</u> needed.

Teams must be aware that, if activated, the SS will be put on hold and medical help sent immediately.

If this point were not to be respected, teams could be summoned in front of the FFSA disciplinary commission by the chairman and/or officials.

7.6.P Parc Fermé

Cars having no waterproof doors (nets) or SSV cars will be allowed to cover up their cars to protect them from any bad weather.
